The Gloucestershire County Council (B4432 Symonds Yat Road, English Bicknor) (Waiting Restrictions) Order 1991

Notice is hereby given that on 13th September 1991, the Gloucestershire County Council, in exercise of its powers under the Road Traffic Regulation Act 1984, made an Order the effect of which is to prohibit any vehicle from waiting in that length of Symonds Yat Road (B4432) in the parish of English Bicknor, which extends from a point 140 metres south of the centre point of its junction with the southern access road leading to Symonds Yat Tourist Centre, for a distance of 655 metres in a generally north-westerly direction between the hours of 8 a.m. and 6 p.m.

EAST HERTFORDSHIRE DISTRICT COUNCIL

The East Hertfordshire District Council (Pay and Display Parking Places) (Amendment) (No. 10) Order 1991 and East Hertfordshire District Council (Parking Places) (Amendment) (No. 3) Order 1991.

Notice is hereby given that the East Hertfordshire District Council propose to make the above-mentioned Orders under the provisions of sections 35(1), (3) and (6) of the Road Traffic Regulation Act 1984.

The effect of these Orders will be:

- (1) to change the operation of the Council's Gascoyne Way Multi-storey and Causeway Car Parks, respectively in Hertford and Bishop's Stortford, as follows:

(a) *The Causeway Car Park, Bishop's Stortford:* This car park will convert to pay and display operation. The current scale of charges will remain unchanged.

(b) *Gascoyne Way Multi-storey Car Park, Hertford:* This car park currently provides long stay parking at a fixed charge. The above Order will provided for a change in its operation as follows:

- (i) Monday to Friday, short stay parking on the lower two floors and long stay (including season tickets) parking on the upper two floors, and
- (ii) Saturday, short stay parking on the lower three floors, with long stay (no season tickets on the upper (fourth) floor).

The charging structure at this car park will thus be:
