## TOWN AND COUNTRY PLANNING ACT 1990

*Proposed Pedestrianisation of a Highway at Stockport*

The Secretary of State for Transport hereby gives notice that on the application of the Stockport Metropolitan Borough Council he proposes to make an Order under section 249 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on part of Cheadle Old Road, Edgeley, Stockport.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:

- for police, ambulance or fire brigade purposes;
- in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984;

and where the vehicle is:

- a vehicle being used by the Local Authority in pursuance of their statutory powers and duties and
- a pedal cycle.

## TOWN AND COUNTRY PLANNING ACT 1990

*Proposed Stopping-up of a Highway at Stockport*
