The Borough of Rugby (Off-Street Parking Places) (No. 2) Order 1991

Notice is hereby given that the Rugby Borough Council propose to make the Borough of Rugby (Off-Street Parking Places) (No. 2) Order 1991. The effect of this new Order will be that the existing Borough of Rugby (Off-Street Parking Places) Order 1991 will be revoked. The following amendments will be made to the existing

- 1. There is to be an increase in the parking charges for all short stay car parks. The charge for parking for a period not exceeding one hour will be increased to 30 pence. Charges for parking between one and three hours will remain at 50 pence. Charges for parking between three and six hours will be increased from £1-30 to £1-40, and parking for between six and ten hours will be increased by ten pence to £2.10.
- 2. There will also be an increase in parking charges for all the long stay car parks. For vehicles not exceeding three tonnes unladen weight, the charge for parking for a period not exceeding one hour will be increased to 30 pence. Charges for parking between one and five hours will remain at 50 pence and parking for five to ten hours will be increased by ten pence to 90 pence.

In respect of vehicles exceeding three tonnes unladen weight parked from 8 a.m. to 4 p.m. the charge will remain at £1.50. For vehicles which park after 4 p.m. and up to 8 a.m. the next day the charge will remain at £4.

- 3. There is to be a £5 increase in the excess charge which will become £30, with £15 payable if payment is within five days of the charge being incurred. As regards vehicles left for longer than the period for which payment was made, the excess charge is reduced to £6 providing payment is made the next working day.
- 4. In line with the John Barford Car Park, charges will be payable at all car parks on statutory Bank Holidays, except for Christmas Day and Boxing Day. Charges are not however payable on Sundays.
