(Prohibition of Vehicular Through Traffic) Order 1991*

Notice is hereby given, that Spelthorne Borough Council, acting as agent for and on behalf of Surrey County Council, propose to make permanent under section 1 of the Road Traffic Regulation Act 1984, the Spelthorne Borough Council (Yew Trees, Shepperton) (Experimental Prohibition of Vehicular Through Traffic) Order 1990.

*The Spelthorne Borough Council (Staines Road West, Windmill Road
and Cadbury Road, Sunbury) (Various Traffic Management
Measures) Order 1991.*

Notice is hereby given, that the Council of the Borough of Spelthorne intend to make the above Order under section 1 of the Road Traffic Regulation Act 1984. The effect of the Order is as follows:

(i) *Staines Road West/New Access Road*

1. No person shall cause any vehicle proceeding in the westbound carriageway of Staines Road West, to make a "U" turn at the junction with the new access road.
2. No person shall cause any vehicle proceeding in an easterly direction in Staines Road West, to make a right turn into the new access road.

(ii) *Staines Road West/Windmill Road/Cadbury Road*

1. Every person causing any vehicle to proceed in a northerly direction in Windmill Road, between island 1 and island 2, shall thereupon cause that vehicle to turn right into Staines Road West.
2. Every person causing any vehicle to proceed in a northerly direction in Windmill Road, between its western kerb-line and island 1, shall thereupon cause that vehicle either to turn left into Staines Road West or to continue in a northerly direction into Cadbury Road.
