TOWN AND COUNTRY PLANNING ACT 1990

Stopping-up of Highways at Fazeley

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 147 of the above Act to authorise the stopping-up of lengths of Plantation Lane and the Green, Fazeley, Lichfield, Staffordshire, to enable the development of a new hospital complex to be carried out by West Midlands Regional Health Authority in accordance with procedures laid down in Department of the Environment Circular 18/84 (Crown Land and Crown Development).

The proposed Order will require the improvement of existing highway and the provision of a new highway maintainable at the public expense, for which the highway authority is to be Staffordshire County Council.
