*The Borough of Blackburn (Prohibition and Restriction of Waiting) (Various Streets, Blackburn) Order 199*

Notice is hereby given that the Blackburn Borough Council, pursuant to arrangements made under section 101 of the Local Government Act 1972, with the County Council of Lancashire, in exercise of the powers of the said County Council, propose to make the above Order under the Road Traffic Regulation Act 1984, the effect of which will be to prohibit and/or restrict the waiting of vehicles on the streets set out in Schedules 1, 2, 3 and 4 to this notice and to revoke the Orders to the extent specified in Schedule 5.

*Prohibition of Waiting at any time*

*Cleaver Street*, north-westerly side, from a point opposite the centreline of George Street East for a distance of 40 metres in a north-easterly direction.

*Cleaver Street*, south-easterly side, from its junction with George Street East for a distance of 35 metres in a north-easterly direction.

*Nab Lane*, south side, from its junction with Montague Street to its junction with Little Peel Street.

*Nab Lane*, north side, from its junction with Montague Street for a distance of 15 metres in a westerly direction.

*Nab Lane*, north side, from its junction with Little Peel Street for a distance of 15 metres in an easterly direction.

*Little Peel Street*, east side, from its junction with Barley Lane to its junction with Heyhurst Road.

*London Road*, south side, from the westerly boundary of 124 London Road to the westerly boundary of 112 London Road.

*Salford*, south side, from its junction with Railway Road to its junction with Cicely Lane.

*Shear Bank Road*, both sides, from its junction with Preston New Road for a distance of 10 metres in a northerly direction.

*Sutton Street*, both sides, from its junction with Preston Old Road to its junction with Back Preston Old Road.

*East Street*, both sides, from its junction with Preston Old Road to its junction with Bank Preston Old Road.

*York Terrace*, both sides, from its junction with Preston Old Road for 15 metres in a north-westerly direction.

*Prohibition of Waiting Monday to Friday 8.30 a.m. to 4 p.m.*

*Arran Avenue*, north side, from the easterly boundary of 110 Arran Avenue to the westerly boundary of 110 Arran Avenue.

*Arran Avenue*, south side, from the easterly boundary of 153 Arran Avenue to the westerly boundary of 153 Arran Avenue.

## SCHEDULE 4

*Waiting Limited to 1 hour in 2 between the hours of 8 a.m. to 6 p.m. on Monday to Saturday*

*Nab Lane*, north side, from a point 15 metres east of its junction with Little Peel Street to a point 15 metres west of its junction with Montague Street.

*Little Peel Street*, west side, from its junction with Barley Lane to its junction with Heyhurst Road.

## SCHEDULE 5

*Waiting Restricted to 20 minutes in 1 hour between the hours of 8 a.m. and 6 p.m. on Monday to Saturday*

*Shear Bank Road*, both sides, from a point 10 metres north of its junction with Preston New Road to a point 5 metres south of its junction with Clarence Street.
