(Prohibition of Driving and Restriction of Waiting) Order 1991.*

*The County of Cornwall (Newquay) (Street Parking Places)
Order 1991*

Notice is hereby given that the Council propose to make the above Orders to regulate traffic at Newquay by:

(i) prohibiting the waiting of vehicles:

- (a) at any time in the lengths of road specified in the First Schedule hereto;
- (b) between 9 a.m. to 9 p.m. daily in the lengths of road specified in the Second Schedule hereto;
- (c) between 9 a.m. to 9 p.m. daily during the period 1st May to 30th September (both dates inclusive) in each year in the length of road specified in the Third Schedule hereto;
