To prohibit the waiting and the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 a.m. and 3.45 p.m. to 6 p.m., Monday to Saturday and to prohibit the waiting of vehicles for more than 1 hour in any 4 hours between the hours of 9.15 a.m. and 3.45 p.m., Monday to Saturday on part of Mutley Plain;
9. To prohibit the waiting and the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 a.m., Monday to Saturday and to prohibit the waiting of vehicles for more than 1 hour in any 4 hours between the hours of 9.15 a.m. and 5 p.m., Monday to Saturday on parts of Drake Circus and North Hill;
10. To prohibit the waiting and the loading and unloading of vehicles between the hours of 3.45 p.m. to 6 p.m., Monday to Saturday and to prohibit the waiting of vehicles for more than 1 hour in any 4 hours between 8 a.m. to 3.45 p.m., Monday to Saturday on part of North Hill;
11. To prohibit the waiting and the loading and unloading of vehicles between the hours of 8 a.m. and 9.15 a.m., Monday to Saturday on part of Mannamead Road;
12. To revoke in their entirety the Orders specified in Schedule 1 to this notice; and
13. To revoke parts of the Orders specified in Schedule 2 to this notice, full details of which are set out in the proposed Order.

Exceptions will be provided in the Order permitting waiting for the purposes of boarding and alighting, building and demolition, roadworks and the maintenance of essential services and for vehicles used by disabled persons in accordance with the "Orange Badge" Scheme.

Exception will be provided in the Order permitting waiting for the purposes of loading and unloading other than in the periods on which loading and unloading is banned as set out above.

A copy of the proposed Order, a map showing the roads to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order may be inspected during normal office hours at the address given below.

Objections to the proposals together with the grounds on which they are made must be sent in writing to the undersigned by 28th November 1991.

## DORSET COUNTY COUNCIL

### *The County of Dorset (Various Streets, Gillingham) (Restriction of Waiting and Limited Waiting) Order 1980 (Amendment) Order 1991*

Notice is hereby given that the Dorset County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3), 4(2) and 124(1)(d) of the Road Traffic Regulation Act 1984.

The effect of the Order will be to:

- (a) Revoke those parts of "The County of Dorset (Various Streets, Gillingham) (Restriction of Waiting and Limited Waiting) Order 1980" relating to School Road on its eastern and southern side.
- (b) Prohibit waiting at any time on School Road on its eastern and southern side between points 78 metres and 98 metres north-east of its junction with High Street.
- (c) Restrict waiting between the hours of 8 a.m. and 6 p.m. Monday to Saturday on School Road between a point 98 metres north-east of its junction with High Street and its junction with School Lane.
- (d) Limit waiting for more than 30 minutes (return prohibited within 30 minutes) between the hours of 8 a.m. and 6 p.m. Monday to Saturday on School Road between a point 46 metres and 78 metres north-east of its junction with High Street.

Exemptions will permit waiting for, picking up or setting down passengers, loading or unloading goods, disabled persons' vehicles bearing the relevant orange badge, post office vehicles delivering or collecting mail, emergency service vehicles and vehicles in connection with any building or demolition operation, the maintenance of the road, the supply of gas, water or electricity and works to any telegraphic line.

Full details of this proposal are contained in the Draft Order which together with a plan showing the lengths of road affected and a statement of the Council's reasons for proposing to make the Order, may be inspected Monday to Friday, during normal office hours at Transportation and Engineering Department, Dorset County Council, County Hall, Dorchester, and Chief Executive's Office, North Dorset District Council, Nordon, Salisbury Road, Blandford.

Should you wish to make any observations on this proposal (whether you support or object to the proposal) you should make them in writing to the undersigned by 28th November 1991. Any observation must specify the grounds thereof.
