The Corporation of London Revision of traffic movements in Liverpool Street and Old Broad Street

Notice is hereby given, that, the Common Council of the City of London on 8th November 1991, made the City of London (Prescribed Routes) (No. 3) Traffic Order 1991, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. Notice of the Common Council's intention to make the Order was first given in Issue No. 52662 of the *London Gazette* on 19th September 1991, ref. 774, page 14274 and the effect of the Order is the same as given in that Notice.

3. The general effect of the Order will be to:

- (a) restore two way working for vehicles in Old Street, between Liverpool Street and London Wall/Wormwood Street;
- (b) compel vehicles proceeding in Liverpool Street on reaching the junction with Old Broad Street to continue in a westerly direction in Liverpool Street;
- (c) compel vehicles proceeding southbound in Old Broad Street to proceed ahead into Old Broad Street, south of London Wall/Wormwood Street;
- (d) compel the left turn by vehicles from Old Broad Street into Liverpool Street;
- (e) compel the right turn by vehicles from the access road leading to Liverpool Street Bus Station into Liverpool Street.

4. The requirements referred to in sub-paragraph 3(d) and (e) above will not apply to vehicles being used to provide an authorised bus service.

5. Exemption will be provided in the Order:

- (a) in respect of anything done with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the City Police.

6. A copy of the Order, which will come into operation on 16th November 1991, of the City of London and Hackney (Prescribed Routes) (No. 1) Traffic Order 1989, and of a plan indicating the affected streets, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of the 6 weeks from the date on which the Orders were made, in Room 123 West, The Guildhall, London E.C.2.

7. Copies of the Order may be purchased from the City Engineer's Department, Guildhall, London E.C.2.

8. Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1984, or that any of the relevant regulations made thereunder has not been complied with in relation to the Order may, within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.
