

## SCHEDULE II

In this Schedule:

(a) The permitted classes of vehicles are as follows:

- (i) Solo Motor Cycles.
- (ii) Registered Disabled Vehicles.
- (iii) Motor Cars.
- (iv) Motor Cycle combinations.
- (v) Motor vehicles not exceeding 3.5 tonnes GVW or 5.5 metres in length.
- (vi) Trailers and Caravans.
- (vii) Motor vehicles exceeding 3.5 tonnes GVW and 5.5 metres in length.
- (viii) Coaches.
- (ix) Boat trailers not exceeding 3.5 tonnes GVW or 5.5 metres in length.

(b) The permitted classes of vehicles must wait wholly within a parking bay set aside for that class of vehicle.

(c) The period of operation of the parking place is that which appears in this Schedule save that the Council may at its discretion suspend the operation of this Order in relation to the whole or any part of any parking place at any time and for whatever purpose it deems fit. This is without prejudice to the Council's right under Article 15 of the Order to close the parking place or one or more parking bays within the parking place.
