*Destruction of Records held by Official Receivers London
Notice to Insolvency Practitioners*

Following a review by staff at Official Receivers London, it has become apparent that a considerable volume of records is being stored when such records are unlikely to be of further interest to anyone.

Or London therefore intends to carry out the mass destruction of records for all cases prior to 1990 unless the records of particular cases are positively identified for retention.

The Official Receiver should only be storing records in those cases where he is Liquidator or Trustee. If a practitioner has been appointed, the records should have been removed by the practitioner or, if left in the same storage facilities, responsibility for payment should have been taken over by the practitioner.

Could practitioners please consider and check whether any records for which they are now responsible have been inadvertently left with the Official Receiver and, if so, make arrangements to remove them by 31st December 1991, or acknowledge responsibility for payment of the storage charges after that date.

Some time early next year all records for 1985-1989 cases not identified by the Official Receiver's staff for retention will be destroyed.

A similar exercise will subsequently be carried out for 1990 and 1991 cases. (30 SI)
