EAST SUSSEX COUNTY COUNCIL

The East Sussex (Hangleton Link Road, Hove) (Traffic Regulation) Order 1991

Notice is hereby given that East Sussex County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3), 3(2), 4(1), 4(2), 82(2) and 83(2), 84(1) and (2) of the Road Traffic Regulation Act 1984, as amended, which will create the following traffic regulations along the Hangleton Link Road at Hove:

- 3. The remainder of the Hangleton Link Road is to be subject to the national speed limit for single carriageway roads-60 m.p.h. Therefore, this stretch of road will be derestricted to prevent a 30 m.p.h. limit which otherwise would be imposed by the system of street lighting.
