*Stopping-up of Highway Verges C23, between Seamer and Tame  
Bridge, Stokesley*

Notice is hereby given that North Yorkshire County Council, being the highway authority for the county of North Yorkshire, intends to apply to the Magistrates' Court for the Petty Sessional Division of Stokesley at the Court House, High Street, Stokesley, at 10 a.m., on Monday, 20th January 1992, for an Order under section 116 of the Highways Act 1980, to authorise the stopping-up of parts of the verges of the Classified Road C23, between Seamer and Tame Bridge, near Stokesley, on the ground that they are unnecessary. The verges concerned are as follows: an area of verge on the north-eastern side of the C23 commencing at Grid Reference 6009-0833 and proceeding in a generally north-western direction for 1,040 metres to Grid Reference 5044-0914, subject to an 8 metre wide length of highway being retained at the entrance to the gypsy site at Grid Reference 5056-0894; and an area of verge on the south-western side of the C23 from Grid Reference 5079-0861 and proceeding in a generally north-westerly direction for 335 metres to Grid Reference 5057-0887 subject to the retention of a public footpath at Grid Reference 5065-0875.

A plan showing the proposal has been deposited at County Hall, Room 7, Northallerton, and at Stokesley Library, Manor House, Manor Close, Stokesley, and may be inspected, free of charge, during normal office hours.
