The County of Cornwall (St. Austell) (Holmbush) (Restrictions on Waiting) Order 1991

Notice is hereby given that the Council propose to make the above Order to regulate traffic at St. Austell by prohibiting the waiting of vehicles:

- (a) at any time in the lengths of road specified in the First Schedule hereto; and
- (b) between 8 a.m. to 6 p.m. daily in the lengths of road specified in the Second Schedule hereto.

Exceptions will be provided in favour of disabled persons vehicles in accordance with the "orange badge" Scheme and to allow boarding and alighting; loading and unloading; delivery and collection of postal packets; statutory powers or duties; building operations; works on roads and services; the taking in of petrol etc, from a garage; and funerals.

No waiting at any time

1. *St. Austell-St. Blazey Road (A390)*:
 - (a) northern side:
 - (i) from the roundabout at the junction with Mount Charles Road for a distance of 158 yards in an easterly direction;
 - (ii) from a point 190 yards east of the roundabout at the junction with Mount Charles Road to a point 62 yards north-east of the junction with Bucklers Lane;
 - (b) southern side:
 - (i) from the roundabout at the junction with Mount Charles Road to a point 90 yards north-east of the junction with Holmbush Arch Road;
 - (ii) between points 121 yards south-west and 61 yards north-east of a point opposite the junction with Bucklers Lane.
2. *Holmbush Arch Road (Unclassified)*, between its junctions with the St. Austell-St. Blazey Road (A390) and Church Road/Crinis Road.

SECOND SCHEDULE

No waiting 8 a.m. to 6 p.m. daily

1. *St. Austell-St. Blazey Road (A390)*:
 - (a) northern side between points 158 yards and 190 yards east of the roundabout at the junction with Mount Charles Road;
 - (b) south-eastern side from a point 90 yards north-east of the junction with Holmbush Arch Road to a point 121 yards south-west of a point opposite the junction with Bucklers Lane.
2. *Daniels Lane (Class III)*, from its junction with the St. Austell-St. Blazey Road for a distance of 180 yards in a northerly direction. (505)
