- 2. an Order under sections 10 and 12 of the Highways Act 1980, providing that three seperate lengths of the A36 Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by the Secretary of State to the County Council of Wiltshire (who will become the highway authority responsible for those lengths) that the new trunk roads are open for through traffic; and
- 3. an Order under sections 12, 14 and 125 of the Highways Act 1980, authorising him to:

(a) improve, raise, lower or otherwise alter highways,

(b) stop up highways,

(c) construct new highways,

(d) stop up private means of access to premises, and

(e) provide new means of access to premises,

all on or in the vicinity of the route of the new trunk road on the main route mentioned above and providing for the transfer of the new highways to be constructed to the County Council of Wiltshire as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.
