- (b) prohibit waiting at any time on the north-east side of Emmott Lane from its junction with Keighley Road for 25 metres in a north-westerly direction;
- (c) prohibit waiting at any time on the north side of Keighley Road from its junction with Emmott Lane for 5 metres in a southwesterly direction:
- (d) prohibit waiting at any time on the north side of Keighley Road from its junction with Emmott Lane for 5 metres in a north-easterly direction.
