##### *The Wigan Borough (Victoria Street, Leigh) (Restriction of Waiting) Order 1992*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Victoria Street, Leigh) (Restriction of Waiting) Order 1991.

The effect of the Order will be to introduce restricted waiting on Victoria Street at the following points:

- (i) North side, from the junction with Kirkhall Lane for a distance of 65 metres in a westerly direction;
- (ii) North side, from a point 85 metres west of Kirkhall Lane for a distance of 53 metres in a westerly direction;
- (iii) North side, from a point 158 metres west of Kirkhall Lane for a distance of 22 metres in a westerly direction.

There will be limited exceptions permitting vehicles to wait:

- (a) To enable people to board or alight;
- (b) For the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) For local authority, North West Water Ltd. and Post Office purposes;
- (d) If the vehicles are fire service or police vehicles of ambulances;
- (e) To take on fuel, water or air at any garage.
- (f) For the delivery or collection of goods and for loading or unloading.
