

(29) Land off Western Way (the new Cathedral and Quay Car Park).

The general nature and effect of the proposed Order is as follows:

(a) To consolidate into one Order the current provisions and pay and display charges contained in the Council's existing parking place Orders listed in the First Schedule hereto which relate to the car parks situate at the locations in the City of Exeter numbered (1) to (29) above and to revoke those orders to facilitate such consolidation.

(b) To amend the manner in which the City Council recovers the Standard Charge (being the penalty charge payable by persons contravening the Orders) by providing that the registered owner of any vehicle left in any of the car parks in contravention of any of the terms of this Order shall be liable for the standard charge being deemed to be the driver for the purposes of this Order in addition to the driver (if different) at the discretion of the Council.

(c) To make provision for the Council's new car park known as the Cathedral and Quay Car Park situate off Western Way (formerly Lower Coombe Street Car Park) for the purpose of regulating its public use and to implement a variable system of pay and display charges as detailed in the Second Schedule hereto.

Full details of these proposals are in a draft Order which together with a statement of the Council's reasons for proposing to make the Order plans identifying the location of each of the car parks listed above may be inspected at the Phase I reception of the City Council at the address below between 9 a.m. and 5 p.m. on normal working days.

If anyone wishes to object to this proposed Order or otherwise make representations they may do so by letter to the undersigned not later than 17th December 1991.

All objections and other representations must be made in writing and all objections must specify the grounds on which they are made.
