That Stephen Paul Bean be restrained whether by himself his servants or agents or otherwise howsoever until further Order from in any way whatsoever dealing with the sum of $\pounds 313,850.00$ held in the following bank accounts:

(a) Number 210-269 held at the Commonwealth Bank of Australia, Sydney, Australia, in the name of Stephen Paul Bean.
(b) Number 195634 held at the Commonwealth Bank of Australia, Sydney, Australia, in the name of Stephen Paul Bean.
(c) Number 71352105 held at the Midland Bank Plc., St. Peter's Port, Guernsey, in the name of Stephen Paul Bean.

For the avoidance of doubt, Stephen Paul Bean may deal with the contents of the aforementioned accounts save for the sum of $\pounds 313,850.00$ held collectively therein. Thus, the balance of these three accounts collectively shall not fall below the sum of $\pounds 313,850.00$.

And should the contents of these bank accounts have been transferred to other accounts held with different banks wheresoever such banks are situate throughout the world prior to the making of this Order, the said Stephen Paul Bean is restrained from dealing with the contents of those accounts up to the value of £313,850-00.

And furthermore should the accounts enumerated at (a), (b) and (c) of this paragraph above contain less than $\pounds 313,850.00$ but there be other bank accounts held in the name of Stephen Paul Bean and those accounts wherever they may be throughout the world contain funds originally transferred from bank accounts held in the name of Cosmic Associates Inc. of Panama, Tees Europe of Guernsey, or Tees Europe of the United States of America, then the said Stephen Paul Bean is restrained from dealing with such accounts to the extent that the contents thereof in sum with the contents of the accounts identified above or accounts to which the contents of the accounts identified above have been transferred prior to the making of this Order, amount to £313,850-00.

That within seven days of the date of this Order Stephen Paul Bean repatriate unto the United Kingdom the sum of £313,850 00 and deposit the same into bank account number 80145548 held at Barclay's Bank Plc., Devizes Branch, 3 St. John's Street, Devizes, Wiltshire SN10 1BQ, in the name of R. J. Bean.

Should you wish to view the said Order of the High Court of Justice, Queen's Bench Division, then you may do so by way of appointment made with the Crown Office, Royal Courts of Justice. The Strand, London WC2A 2LL.

Should you wish to challenge the said Order of the High Court of Justice, Queen's Bench Division, then you may do so within fortyeight hours of notice being given to the Crown Prosecution Service, Central Confiscation Unit, 10 Furnival Street, London EC4A 1PE.

Be advised that should you disobey the Order of the High Court of Justice, Queen's Bench Division as reproduced above, you will be liable for process of execution for the purpose of compelling you to obey the same.
