- (i) that the authorization granted by the Order is not empowered to be granted, or
- (ii) that there has been a failure to comply with any statutory requirement relating to the order.

### SCHEDULE 1

NOTE: (a) The land comprised in each item in this Schedule and Schedules 2, 3, and 4 is identified on the plan referred to in the made Compulsory Purchase Order by means of the number or numbers shown in brackets against that item in these Schedules.

(b) References to ownership are references to ownership or reputed ownership at the time of preparation of the made Compulsory Purchase Order and stated only for the purpose of identification of the land.

#### *In the London Borough of Greenwich*

Part of open park land and paths on the south of British Rail's Bexleyheath Branch Line known as Eltham Park South (1). Part of open park land and paths on the south of British Rail's Bexleyheath Branch Line known as Eltham Park South (1A). The right to construct and maintain a footbridge over railway lines and part of northern slope to the cutting of the British Rail's Bexleyheath Branch Line (2). The right to construct and maintain a bridge over part of railway line and part of the slopes to the cutting of the British Rail's Bexleyheath Branch Line (7B). The right to construct and maintain a bridge over part of railway line and part of slopes to the cutting of the British Rail's Bexleyheath Branch Line (8A). All interests (other than those of the Crown) in parts of woodland drain and grass area on the south of the British Rail's Bexleyheath Branch Line known as Eltham Warren Golf Course (9 and 9A). Part of embankment, formerly part of scrub land on the north side of Eltham Warren Golf Course (9B) (in unknown ownership). Part of rear garden of 115 Riefield Road (10). All interests (other than those of the Crown) in part of rear garden of 117 Riefield Road (11 and 11A). All interests (other than those of the Crown) in part of rear garden of 119 Riefield Road (12 and 12A). Part of rear garden of 121 Riefield Road (13 and 13A). Part of rear garden of 123 Riefield Road (14 and 14A). Part of woodland known as Oxleas Wood, north of Welling Way (23B, 24A, 24B, 24C, 25, 25A and 25B). Part of woodland known as Oxleas Wood and footpath north of Welling Way (24). Half width of Shooters Hill adjoining woodland known as Oxleas Wood (24D). Part of woodland known as Oxleas Wood, south of Shooters Hill (25C and 25D). Part of front garden of 341 Shooters Hill and part of adjoining half width of Shooters Hill (26). Part of nursery gardens and part of path at rear of 341 Shooters Hill (26A).
