NEW TOWNS ACT 1981

The New Town of Milton Keynes Extinguishment of Public Rights of Way over lengths of Bridleway No. 10 (Woolstone) and Leisure Route (River Ouzel-Willen Lake).

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1981, has made an Order extinguishing, as from the date of the Order, the Public Rights of Way over the following routes shown coloured red on the map No. IED/1328/1 referred to herein:

That length of Bridleway No. 10 (Woolstone) coloured red on the map and running from a point marked A on the map, approximately 70 metres north-east of the Community Centre, Woolstone, in a north-easterly direction for approximately 55 metres and then in a south-easterly direction for approximately 290 metres to a point marked B on the map, the northern end of the footbridge crossing the River Ouzel.

That length of Leisure Route coloured red on the map and running from a point marked C on the map, approximately 115 metres north-west of the northern end of the footbridge crossing the River Ouzel, in a south-westerly direction for approximately 220 metres to a point marked D on the map, the route's junction with the Leisure Route adjacent to the River Ouzel, approximately 200 metres south-west of the said footbridge.

The Order is dated 25th November 1991, and a copy of it and of the map referred to in it showing the rights of way which have been extinguished may be inspected at the offices of the Milton Keynes Development Corporation, Saxon Court, 502 Avebury Boulevard, Milton Keynes MK9 3HS during normal office hours.

TOWN AND COUNTRY PLANNING ACT 1990

Proposed Stopping Up of a Highway at Trafford Park, Manchester

The Secretary of State for Transport hereby gives notice that on the application of Trafford Park Development Corporation he proposes to make an Order under section 248 of the above Act to authorise the stopping up of a length of Fraser Road, Trafford Park, Manchester to enable development consisting of the construction of an access road to the proposed Euroterminal at Trafford Park, Manchester to be carried out in accordance with planning permission granted by Trafford Park Development Corporation under Part III of the said Act.

TOWN AND COUNTRY PLANNING ACT 1990

Stopping Up of Highways at Manchester

The Secretary of State for Transport hereby gives notice that on the application of Lovell Partnerships he has made an Order under section 247 of the above Act entitled "The Stopping up of Highways (City of Manchester) (No. 4) Order 1991, authorising the stopping up of various footpaths and highways at Cheetham Hill, Manchester, in an area to the west of Waterloo Road and east of Highclere Avenue and including Dalmain Walk, Stolford Walk, Canfield Walk and parts of Kilmington Drive.
