

HIGHWAYS ACT 1980

The A435 Trunk Road (Norton Lenchwick By-pass Side Roads) (Supplementary) Order 19

The Secretary of State for Transport hereby gives notice that he proposes to make under sections 14 and 125 of the Highways Act 1980 an Order which will:

- (a) authorise him:
- (i) to stop up highways;
 - (ii) to construct new highway;
 - (iii) to stop up private means of access to premises;
 - (iv) to provide new means of access to premises;
- all on or in the vicinity of the route of the above-mentioned new trunk road, and
- (b) provide for the transfer of the said new highways to the highway authority specified thereon in the Order as from the date on which he notifies that authority that the new highway has been completed and open for through traffic.

WMT 244/10/65/2/07 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

The Secretary of State for Transport hereby gives notice that he has made Orders under sections 10, 12, 14, 41 and 125 of the Highways Act 1980, the effect of which are to:—

- (a) provide that a road about 12.2 km in length which he proposes to construct along the following route shall become a trunk road as from the date when the Order comes into force. The route lies between Evesham and Alcester in the counties of Hereford and Worcester and Warwickshire. It starts at the roundabout junction between the A435 Evesham Bypass and the trunk road (known as Evesham Road) in the county of Hereford and Worcester and proceeds generally northerly passing to the south and east of the villages of Harvington and Abbots Salford following a route close to and east of the dismantled railway to a point about 100 metres west of Salford Bridge on the (B439) Salford Road. It continues from this point in a generally northerly direction on to a point south of Oversley Mill to connect with the Alcester Bypasses in the county of Warwickshire.
- (b) provide that the length of road of about 11.9 km consisting of the A435 in the counties of Hereford and Worcester and

Warwickshire from a point on the Evesham Bypass south of Norton, 190 metres east of the junction known as Twyford Roundabout, in the county of Hereford and Worcester in a generally north easterly direction to its junction with the A422 at Arrow in the county of Warwickshire shall cease to be a trunk road as from the date on which the Secretary of State notifies the County Councils of Hereford and Worcester and of Warwickshire (who will become the highway authority responsible for these lengths) that the road referred to at (a) above is open for through traffic;

- (c) provide that the length of road of about 0.38 km consisting of the A422 in the county of Warwickshire which runs from a point approximately 275 metres north of arrow Church south westwards to its junction with the A435 at Arrow in the county of Warwickshire shall cease to be a trunk road as from the date on which the Secretary of State notifies the County Council of Warwickshire (who will become the highway authority responsible for that length) that the road referred to at (a) above is open for through traffic;

- (d) authorise him:
- (i) to improve, raise, lower or otherwise alter highways,
 - (ii) to stop up highways,
 - (iii) to construct new highways,
 - (iv) to stop up private means of access to premises, and
 - (v) to provide new means of access to premises.

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein on the ground that they are not within the powers of the Highway Act 1980, or on the ground that any requirement of that Act, or the regulations made thereunder, has not been complied with in relation to the Orders, may, within 6 weeks, from 29th November 1991, or within 8 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.
