

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up and setting down passengers, loading and unloading goods, the maintenance of the roads, and works in connection with the supply of gas, electricity and water and any Telegraphic line.

The Order will come into operation on 3rd December 1991 and a copy of the Order and a plan showing the lengths of road concerned may be inspected at the address given below and the offices of the South Holland District Council, Priory Road, Spalding during normal office hours.

Any person who desires to question the validity of the Orders or of any provision contained therein on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement or the Act or of any Instrument made under it has not been complied with in relation to the Orders may within 6 weeks after 22nd November 1991 make application to the High Court for this purpose.

LINCOLNSHIRE COUNTY COUNCIL

Lincolnshire County Council (Northons Lane—Holbeach) and (various roads - Fleet) (Restricted Roads) Orders 1991

Notice is hereby given that the Lincolnshire County Council has made Orders under sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984, the effect of which will be to impose a 30 m.p.h. speed limit on the following roads in Holbeach and Fleet Hargate:

Length of road in Holbeach

Lengths of road in Fleet Hargate

Eastgate, from the superseded A17 southwards for a distance of about 660 metres, including Eastgate Gardens and Burgess Drive.

Hockles Gate, From the superseded A17 southwards to a point about 100 metres south of Cherry Lane, including Hargate Close.

Cherry Lane, entire length.
Charles Road, entire length.
