If you wish to question the validity of the Order, or of any provision contained in it, on grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it, it has not been complied with in relation to the Order, you may, within 6 weeks from 29th November 1991, apply to the High Court for this purpose.

## SHROPSHIRE COUNTY COUNCIL

*The County Council of Shropshire (40 m.p.h. speed limit) (No. 2) Order 1991*

*The County Council of Shropshire (Hem Lane, Shifnal) (Prohibition of Motor Vehicles) Order 1991*

## SHROPSHIRE COUNTY COUNCIL

*The County Council of Shropshire (Various Roads, Donnington) (Prohibition of Waiting) Order 1991*

Notice is hereby given that on 28th November 1991, the County Council of Shropshire made an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

When this Order comes into effect on 2nd December 1991, waiting will be prohibited at all times in the lengths of roads and on the sides of road specified in the Schedule of this notice.

The usual exemptions, including loading and unloading, will apply. Disabled persons' vehicles displaying the orange badge will be allowed to wait for up to two hours.

*Lengths of Roads and Sides of Road at Donnington in the District of The Wrekin*

1. That length of Donnington Drive which extends from its junction with Humbers Roundabout for a distance of 75 metres in a northerly direction.

2. That length of Humber Lane which extends from its junction with Humbers Roundabout for a distance of 360 metres in an easterly direction.
