The East Sussex (A22, Hailsham) (Derestriction) Order 1991

Notice is hereby given that East Sussex County Council have made an Order on 27th November 1991 coming into force on 2nd December 1991 under section 82(2) and 83(2) of the Road Traffic Regulation Act 1984, as amended, which derestricts the length of carriageway on the A22, Hailsham as listed below. This removes the 30 mph speed limit at the approaches to the new Grovelands roundabout which otherwise automatically exists due to the system of street lighting.

A22, Hailsham: Derestriction from a point 102 metres south of Grovelands roundabout to a point 106 metres north of the roundabout.

Notice is hereby given that East Sussex County Council propose to make an Order under sections 1(1) and (2) 12(1) to (3), 32(1) and 35(1) and (3) of the Road Traffic Regulation Act 1984, as amended, which will extend the No Waiting "At any time" restrictions and create 2 disabled parking places in certain lengths of road in Newhaven.

(1) No waiting "At any time"

- (a) First Avenue, north-west side, from its junction with Northdown Road, north-eastwards, for a distance of 25 metres.
- (b) Fort Road, south-west side, from a point opposite the boundary between Nos. 1 and 3 Fort Road, south-eastwards, to a point 20 metres north of its junction with the north side of Lorraine Road.
- (c) Murray Avenue, south-west side, from a point 13.7 metres north-west of its junction with the northern kerb-line of Brighton Road, north-westwards, for a distance of 33.3 metres.
