*Traffic Regulation Orders**On Street Parking Place Orders**Notice of Proposal to Make Orders*

Notice is hereby given that the Tonbridge and Malling Borough Council acting as agents of the Kent County Council intend to make Orders under sections 1(1), (2), (3), 45, 124(1) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

the effect of the Orders as proposed will be as follows:

**A. The Tonbridge and Malling Borough Council (Consolidation of Traffic Orders) (Various Roads Tonbridge) (Variation No. 20) Order**

(1) To delete a small length of the existing No Waiting at Any Time Restrictions on the Eastern Side of Lyons Crescent to take account of a new access road being constructed to serve the new Fisher Hall Development.

(2) To delete a portion of the existing No Waiting at Any Time Restrictions on the Eastern and Western sides of Priory Street in consequence of the second order mentioned below.

(3) To impose No Waiting at Any Time Restriction on the Northern and Eastern Sides of Shakespeare Road at its junction with Brook Street.

(4) To impose No Waiting 8 a.m. - 6 p.m. Monday to Saturday Restrictions around the junctions of Shakespeare Road/Burns Crescent and College Avenue/Burns Crescent.

**B. The Tonbridge and Malling Borough Council (Street Parking Places) (Variation No. 8) Order**

To create on the Eastern (fronting Magdalene House) and Western sides (fronting rear of Priory Grove development) of Priory Street for a distance of 20 metres and 30 metres respectively additional on-street parking areas for residential permit holders only between 0930 and 1030 hours Monday to Friday.
