ROAD TRAFFIC ACTS

CAMBRIDGESHIRE COUNTY COUNCIL

The County of Cambridgeshire (Helpston Road, Glinton) (Prohibition of Waiting) Order 1991

Notice is hereby given that on 30th December 1991, the Cambridgeshire County Council made an Order under the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers the effect of which is to prohibit waiting between the hours of 8.30 a.m. to 9.30 a.m. and 3 p.m. to 4 p.m., Monday to Friday, on the following lengths of Helpston Road:

(1) The north side from a point 120 metres east of its junction with Beech Road in an easterly direction for a distance of 25 metres.

(2) The south side from a point 42 metres west of its junction with Beech Road in an easterly direction to its junction with Westbourne Drive.

The standard exemptions covering loading and unloading, boarding and alighting, emergency service vehicles and disabled

persons' vehicles will apply.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order may, within 6 weeks from 30th December 1991, apply to the High Court for this purpose.
