

East Goths are come hither, and the Dacaria Regiment of Infantry of 1200 Men is expected, which are all to be quartered on the Housekeepers here, without any exception of Quality, the Senators not having exempted themselves. Some days ago the Regency published two Placarts which the King lately sent from Turkey: In the one he admonishes his People to render true Accounts of their whole Estates both real and personal to those who are appointed to make the Assessments, and not elude his Majesty's gracious Intention of establishing a just Equality among all his Subjects in their Taxes, by concealing any part thereof, as he is informed many have done; and threatens with his Displeasure those who upon inquiry shall be discovered to have given in false Valuations. The other forbids the receiving hereafter of any Corn or other kinds of Provisions, in lieu of Money, for Taxes; in which manner the Peasants were ever generally allowed to pay theirs. Yesterday the principal Burghers of the City were summoned to the Town-House, where General Meyerfeld in the Name of the Princess and Senate desired an immediate Loan of 50000 Crowns, for some Service which he represented to be of the utmost Importance, assuring them it should be repaid with Interest out of the first Money that comes in of next Yeats Taxes: But the Burghers pleading Inability, he could only get a Promise from some of them that they would endeavour to raise it if possible on their own Credit. This Money, if it can be procured, is designed to be remitted to Hambourg for a present supply of the King's Occasions on his coming into Pomerania, whither General Meyerfeld is in readiness to pass over to his Majesty on the first certain Notice of his Arrival.

Hague, Nov. 30. N. S. The 24th M. Vander Duffen and Count Rechteren, two of their High-Mightinesses Deputies for Regulating the Barrier, having received new Instructions on that Subject, set out for Antwerp as did on the 26th Lieutenant-General Cadogan, who the Night before returned from Amsterdamb. The Advices from Vienna and from Ratisbon, do not give any Account of the King of Sweden's having yet passed through any part of the Emperor's Dominions, on his Journey to Pomerania: But Letters from Stralsund of the 24th Instant, and from Hambourg of the 27th relate, that his Swedish Majesty arrived incognito at Stralsund the 22d, with only one Officer and two Servants; the 23d the Duke Administrator of Holstein set out from Hambourg for Stralsund.

Yesterday the Baron de Beveren, Envoy from the Elector of Triers, had a private Audience of his Majesty; to which he was introduced by the Right Honourable the Lord Viscount Townshend, one of his Majesty's Principal Secretaries of State, and conducted by Sir Clement Cottrell, Master of the Ceremonies.
