TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order with minor modifications under section 247 of the above Act entitled "The Stopping-up of Highways (County of Tyne and Wear) (No. 15) Order 1991" authorising the stopping-up of a triangular shaped area of highway verge of North Road adjoining the eastern end of No. 2 Preston Terrace, North Shields to enable development consisting of a change of use of land from adopted highway to garden/yard to be carried out in accordance with planning permission granted to G. W. Laws, 2 Preston Terrace, Preston Village, North Shields by North Tyneside Council under Part III of the Town and Country Planning Act 1971.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision, contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 20th January 1992 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
