

## HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (Perdiswell Street and Ombersley Road, Worcester) (Prohibition of Waiting) Order 1992*

Notice is hereby given that on 16th January 1992 Hereford and Worcester County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, and of all other enabling powers the effect of which will be to prohibit waiting at any time in those sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester specified in the Schedule to this notice.

Exemptions in the Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and/or unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply and maintenance of any gas, electricity, water and telecommunications apparatus;
- (f) the fire brigade, ambulance or police services;
- (g) the pursuance of statutory powers or duties (if no other road can be conveniently used).

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's "orange badge" scheme for a limited period of two hours, return prohibited within a further period of one hour.

The Order will come into operation on 27th January 1992.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of Parts, I, II or III of Schedule 9 to the Act of 1984 or of any regulations made under the said Part III of Schedule 9 have not been complied with in relation to the Order, may within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

*Sides of lengths of roads in the City of Worcester in the County of Hereford and Worcester*

*Perdiswell Street*, north side, from its junction with A38 Droitwich Road to its junction with Ombersley Road, a distance of approximately 185 metres (607 feet).

*Perdiswell Street*, south side, from its junction with Ombersley Road for a distance of 15 metres (49 feet) in an easterly direction.

*Ombersley Road*, east side, from its junction with Perdiswell Street for a distance of 15 metres (49 feet) in a northerly direction.

## HEREFORD AND WORCESTER COUNTY COUNCIL

*The County of Hereford and Worcester (A44 Whittington Road, Worcester) (Prohibition of use of Gaps in Central Reservation) Order 1992.*

Notice is hereby given that on 16th January 1992 Hereford and Worcester County Council made an Order under sections 1(1) and (2) and 2(1) and (2) of the Road Traffic Regulation Act 1984, and of all other enabling powers the effect of which will be to prohibit any vehicle proceeding in either of the carriageways of A44 Whittington Road, Worcester, to enter or proceed through either of the two gaps in the central reservation between A422 Spetchley Road Roundabout and the Worcester Eastern Orbital Road Roundabout. The gaps referred to are opposite Walkers Lane and the entrances to Worcester College for the Blind/Government Offices.

The Order will come into operation on 27th January 1992.

The alternative route for vehicles affected by this Order will be via either of the two roundabouts named above.

A copy of the Order as made and a copy of the relevant map can be inspected at County Hall, Spetchley Road, Worcester, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the ground that any requirement of that section or of Parts, I, II or III of Schedule 9 to the Act of 1984 or of any regulations made under the said Part III of Schedule 9 have not been complied with in relation to the Order, may within 6 weeks of the date on which the Order was made (such date stated in this notice) make application for the purpose to the High Court.

## HUMBERSIDE COUNTY COUNCIL

*The County of Humberside (Cleethorpes Borough) (Various Roads, New Waltham) (Prohibition of Waiting) Order 1992*

Notice is hereby given that on 2nd January 1992, the Humberside County Council made this Order which will be operative from 27th January 1992, and the effect of which will be to prohibit waiting at anytime in parts of the following roads as specified below:

- (1) *A1098 Station Road*, South side: Extending from a point 15 metres west of the west kerb-line of Pretymen Crescent to a point 15 metres east of the east kerb-line of Pretymen Crescent.
- (2) *Pretymen Crescent*:  
West side, from the south kerb-line of Station Road southwards to a point 15 metres south of the south kerb-line of Charles Avenue a distance of 93 metres.  
East side, from the south kerb-line of Station Road southwards for a distance of 30 metres.
- (3) *Charles Avenue*, both sides, from the west kerb-line of Pretymen Crescent westwards for a distance of 15 metres.
- (4) *Hawthorne Avenue*, both sides, from the east kerb-line of Louth Road eastwards for a distance of 25 metres.

Exemptions will include permission to wait for the purposes of picking up and setting down passengers, loading and unloading, the maintenance of roads, gas, water and electricity supplies, and for police, ambulance and fire brigade purposes.

A copy of the Order and relevant map may be examined during normal office hours at The Records Office, The County Solicitor's Unit, County Hall, Beverley (MG/29851) and The Post Office, New Waltham.

If you wish to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the 23rd January 1992, apply to the High Court for this purpose.

*The County of Humberside (Cleethorpes Borough) (Various Roads, Immingham) (Prohibition and Restriction of Waiting) Order 1992*

Notice is hereby given that on the 23rd January 1992, the Humberside County Council made this Order which will be operative from the 27th January 1992, and the effect of which will be to:

- (a) Prohibit waiting at any time in parts of the following roads as specified:  
Highfield Avenue, Pelham Road, Blossom Way, Pamela Road, Carver Road, Sackville Road, Middleplatt Road and Manby Road By-Pass.
- (b) Prohibit waiting, loading or unloading at any time in part of Pelham Road.
