The South Lakeland Public Path Stopping-up (No. 1) Order 1991

Notice is hereby given that the Secretary of State for the Environment, in exercise of the powers conferred on him under section 247 and section 252 of the Town and Country Planning Act 1990, and all other powers enabling him in that behalf, has made an

Order entitled the South Lakeland Public Path Stopping-up (No. 1) Order 1991.

The effect of the Order is to stop up that part of footpath 575002 which runs from a point marked A on the map hereinafter referred to (grid ref. SD 5078 9586) generally north-east along the field boundary for a distance of 66 metres to point B on the map (grid ref. SD 5083 9590), then generally north-west through point C (grid ref. SD 5080 9593) for a distance of 254 metres to point D (grid ref. SD 5067 9609), and to replace it with new sections of alternative footpath to be created from point E on the map (grid ref. SD 5081 9818) generally south-west along the field boundary on the south side of the stone wall for 170 metres to point D (grid ref. SD 5067 9609), and a section from point F on the map (grid ref. SD 5049 9619) generally south-south-west over the new footbridge over the River Kent for an overall distance of some 390 metres to point G (grid ref. SD 5031 9586). The lines and situations of the existing and proposed sections of footpath are shown on the map annexed to the Order.

A copy of the Order and the map annexed to it has been deposited at the offices of the South Lakeland District Council, and may be inspected free of charge at the Council offices at Stricklandgate House, Kendal, during normal office hours.

Copies of the Order and map may be obtained from the North West Regional Office of the Department of the Environment, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE, (quote Ref. PNW/5166/151/2).

The Order becomes operative as from the date of publication of this notice but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act 1990, or on the ground that any requirement of that Act or of any Regulations made thereunder has not been complied with in relation to the making of the Order he may, under section 288 of the Town and Country Planning Act 1990, within 6 weeks of the publication of this notice, make application for the purpose to the High Court.
