*The County of Wiltshire (Various Roads, Bishopstone) (30 m.p.h. speed limit) Order 1992*

Notice is hereby given that the Wiltshire County Council proposes to make an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984 the effect of which would be to impose a 30 mile per hour speed limit on the following lengths of road:

#### WILTSHIRE COUNTY COUNCIL

*The County of Wiltshire (A363, Town Bridge, Bradford-on-Avon) (Weight Restriction) Order 1992*

Notice is hereby given that the Wiltshire County Council have made an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit heavy commercial vehicles having a gross vehicle weight in excess of 17 tonnes from proceeding along the A363, Town Bridge, Bradford-on-Avon, between its junction with Bridge Street and its junction with The Bullpit.

Exemptions are included in the Order to enable such vehicles to proceed along the length of road concerned in connection with building operations or demolition adjacent to the road, the removal of obstructions, the laying, erection, alteration or repair of any statutory undertakers' apparatus or any telecommunications apparatus, also whilst vehicles are being used in the service of the local authority in pursuance of statutory powers or duties or in the service of the Police Authority, Fire Brigade or Ambulance Service in a case of emergency.

A copy of the Order and Plan may be inspected at the Chief Executive's Department (Legal Division) County Hall, Trowbridge, during normal office hours.

Any person aggrieved by the Order and desiring to question the validity of the Order or of any provision contained in the Order on the grounds that it is not within the powers of the relevant section of the above Act or on the grounds that any requirement of that section or of Part III of Schedule 9 of the Act or any regulation made under the said Schedule has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.

The Order will be operative as from 1st February 1992.
