SCHEDULE 5

Chestnut Road:

North side, from its junction with Torr Lane, westwards for a distance of 22 metres.

South and north sides, from a point 135 metres west of its junction with Limetree Road westwards up to and including its closed western end.

South side from, a point 15 metres west of its junction with Limetree Road eastwards to its junction with Torr Lane.

Torr Lane:

North and north-east sides, from its junction with Outland Road (both northern entry arm and central entry arm) eastwards and south-eastwards to a point 26 metres east of the extended northern kerb-line of Chestnut Road.

South and south-west sides, from its junction with Outland Road (both central exit arm and southern exit arm) eastwards and south-eastwards to a point 42 metres east of the extended northern kerb-line of Chestnut Road (excluding the lay-by situated on the south side of the southern arm approximately 22 metres to 58 metres east of Outland Road).

SCHEDULE 6

Chestnut Road, both sides, from its junction with Outland Road eastwards for a distance of 70 metres.

SCHEDULE 7

Chestnut Road, south side, from a point 70 metres (77 yards) east of its junction with Outland Road eastwards for a distance of 159 metres (174 yards).

DEVON COUNTY COUNCIL

The County of Devon (Pinhoe Road, Exeter) (Reserved Bus Lane) and (Prohibition of Waiting) Order 1992

Notice is hereby given that on 14th February 1992 Devon County Council made an Order under sections 1(1) and (2), 2(1) to 3(3), 4(1) and (2) of the Road Traffic Regulation Act 1984, as published in the *London Gazette*, No. 52590 (ref. DEVON COUNTY COUNCIL

The County of Devon (Yarty Farm Bridge, Stockland/Membury) (Weight Restriction) Order 1992
