The Borough of Southend-on-Sea Various Roads Consolidation of Waiting Restrictions and One-Way Street Order 1973. Schedule 10, Page 10.L.1, Item 1.

The Borough of Southend-on-Sea (Leigh Marshes Access Road) Prohibition of Waiting Order 1988.

Exceptions in the Order permit waiting for the following purposes:

- (a) Picking up or setting down passengers.
- (b) Loading or unloading goods.
- (c) Carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.
- (d) By disabled persons vehicles complying with the conditions set out in the Order.

The Order will come into effect on the 6th March 1992.

Notice is hereby given that the Southend-on-Sea Borough Council propose to make an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit waiting as follows:

*Hours of Prohibition: 24 hours daily*

Thorpe Bay Railway Station Access Road in its entirety both sides from its junction with Barnstaple Road.

*The Borough of Southend-on-Sea (Headland (Headway) East Beach Shoeburyness) (Prohibition of Driving) Order 1991*

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 21st February 1992, pursuant to arrangements under section 101 of the Local Government Act 1972 with the Essex County Council in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit driving as follows:

No person shall cause any vehicle to proceed in the stretch of Highway known as the Headland (Headway) East Beach Shoeburyness from a position approximately adjacent to the access to the Proof and Experimental Establishment southwards to the beach.

The Order will come into effect on 6th March 1992.

*The Borough of Southend-on-Sea (Manilla Road junction with Arnold Avenue and Victoria Road) (Prohibition of Waiting) Order 1991.*

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 21st February 1992, pursuant to arrangements under section 101 of the Local Government Act 1972 with the Essex County Council in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit waiting as follows:

*Hours of Prohibition: 24 hours daily*

*Manilla Road*, both sides, from the east kerb-line of Arnold Avenue eastwards for a distance of 15 metres.

*Manilla Road*, both sides, from the west kerb-line of Victoria Road westwards for a distance of 15 metres.

*Arnold Avenue*, east side from a point 15 metres north of the north kerb-line of Manilla Road to a point 15 metres south of the kerb-line of Manilla Road.

*Victoria Road*, both sides from a point 15 metres north of the north kerb-line of Manilla Road to a point 15 metres south of the kerb-line of Manilla Road.

Exceptions in the Order permit waiting for the following purposes:

- (a) Picking up or setting down passengers.
- (b) Loading or unloading goods.
- (c) Carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.
- (d) By disabled persons' vehicles complying with the conditions set out in the Order.

The Order will come into effect on 6th March 1992.
