TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the diversion of a length of Altofts Lane and an unnamed footpath, Whitwood, Castleford, Wakefield to enable development consisting of a Rail Freight Terminal and Associated Development to be carried out subject to the granting of planning permission.

The proposed Order will require that the new lengths of highways to be provided as the diversion are to be highways maintainable at the public expense, for which the highway authority is to be the City of Wakefield Metropolitan Council.

The proposed Order will also authorise the stopping-up of a private means of access to premises and the provision of new means of access to premises.

During 28 days from 19th March 1992 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Reception Desk, City of Wakefield Metropolitan Council, County Hall, Wakefield and at the Civic Centre, Castleford and may be obatined free of charge from the Department of Transport (quoting ref. YHNMD X4725/35/1/12) at the address stated below.

Within the above-mentioned period of 28 days, any person may by notice to the Secretary of State (ref. YHNMD X4725/35/1/12). at his address at the office of the Director (Transport), Yorkshire and
