HIGHWAYS ACT 1980

The Fishguard—Bangor (Menai Suspension Bridge) Trunk Road (A487) (Diversion at Lower Town, Fishguard) Order 19

The Fishguard—Bangor (Menai Suspension Bridge) Trunk Road (A487) (Diversion at Lower Town, Fishguard, Side Roads) Order 19

The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

- an Order under sections 10 and 106 of the Highways Act 1980 providing:
 - that a road about 0.11 kilometres in length which he proposes to construct at Lower Town, Fishguard, in the county of Dyfed shall become a Trunk Road as from the date when the Order comes into force;
 - that the length of the Fishguard—Bangor Trunk Road to be superseded shall cease to be a Trunk Road as from the date on which notice is given by him to the County Council of Dyfed (who will become the highway authority responsible for that length) that the new length of highway is open for through traffic; and
 - authorisation to construct as part of the road a bridge over the navigable waters of the Afon Gwaun.
- an Order under sections 14 and 125 of the Highways Act 1980 authorising him:
 - to carry out the improvement of highways;
 - to stop up highways;
 - to construct new highways;
 - to stop up private means of access to premises; and
 - to provide new means of access to premises.

All at Lower Town aforesaid.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours from 1st May 1992 to 12th June 1992 at the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff, the Offices of Dyfed County Council, St. Thomas' Green, Haverfordwest, Preseli Pembrokeshire District Council, Cambria House, Haverfordwest and at the County Library, High Street, Fishguard.

Any person may, not later than 12th June 1992 object to the making of either of the Orders by notice to the Secretary of State at the Welsh Office, Highways Directorate, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff, quoting ref. ZB810008-310-1 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
