COLCHESTER BOROUGH COUNCIL

Colchester Borough Council (Various Roads, Colchester) (Prohibition and Restriction of Waiting) Order 1991

Notice is hereby given that Colchester Borough Council, as agents for Essex County Council, have made an Order under section 1 of the Road Traffic Regulation Act 1984, which provides, respectively:

 (i) to prohibit waiting at all times on specified sides of the lengths of road in Schedule 1 to this notice;

(ii) to prohibit waiting between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays inclusive on specified sides of the lengths of road in Schedule 2 to this notice;

(iii) to prohibit waiting between the hours of 9 a.m. and 10 a.m., Mondays to Fridays inclusive on specified sides of the lengths of

road in Schedule 3 to this notice;

(iv) to revoke the restriction of waiting between 8 a.m. and 6 p.m., Monday to Saturday on the length of Hythe Hill, Colchester, on its south side between a point opposite the western boundary of 42 Hythe Hill and a point opposite the western boundary of 44 Hythe Hill, Colchester, and the length of Hythe Hill, Colchester, on its south side from a point 13-7 metres east of its junction with St. Leonard's Road, eastwards for a distance of 29 metres:

(v) to revoke the loading restrictions between 8.30 a.m. and 9.30 a.m., 12.30 p.m. and 2.15 p.m. and 4.30 p.m. and 6.30 p.m. on the north side of St. John's Street, Colchester, outside Nos.

34 and 35 St. John's Street.

The Order will come into operation on 26th May 1992, and brings into effect the proposals advertised in notice No. 770 of Issue 52677 of the *London Gazette* published on 4th October 1991, with the following modifications:

- (i) the removal from the Order of the waiting restrictions insofar as they relate to the specified sides and lengths of Mersea Road, Colchester described in Schedule 1 to the Order; Cotman Road, Colchester described in Schedule 2 to the Order; Mason Road, Colchester described in Schedule 3 to the Order and Clarendon Way, Colchester described in Schedule 5 to the Order;
- (ii) the removal from the Order of the prohibition of waiting at all times insofar as it relates to the specified sides and lengths of Harwich Road, Colchester described in Schedule 1 to the Order and the inclusion in Schedule 2 to the Order of the prohibition of waiting between the hours of 8 am. and 6 p.m., Mondays to Saturdays in Harwich Road, Colchester on its south-eastern side from a point opposite the boundary between 158 and 160 Harwich Road, Colchester north-eastwards for a distance of 20 metres;
- (iii) the removal from the Order of the prohibition of waiting at all times insofar as it relates to the specified sides and lengths of Oaks Drive, Colchester described in Schedule 1 to the Order and the inclusion in Schedule 1 to the Order of the prohibition of waiting at all times in Oaks Drive, Colchester on its west side from a point opposite the boundary between 11 and 13 Oaks Drive southwards for a distance of 17 metres and on its north side from a point opposite the eastern most boundary of 14 Oaks Drive eastwards for a distance of 19 metres.

The Order will not prevent vehicles waiting for the purposes of loading or unloading goods, allowing passengers to board or alight or to enable works to be carried out in the road. Exemptions in the Order also permit the waiting of disabled persons' vehicles in accordance with the "orange badge" scheme.

A copy of the Order with details of the specified lengths of roads and maps showing the lengths of roads to which the Order relates may be inspected at the Council's office at Angel Court, High Street, Colchester, between 9 a.m. and 5 p.m., Mondays to Fridays. Copies are also available for public inspection during normal office hours at the Local Government Library (E Block), County Hall, Chelmsford.

Any person who wishes to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, may, within 6 weeks from 22nd May 1992, make application to the High Court for this purpose.

The County of Cumbria (Various Roads, Great Broughton)
(Prohibition of Waiting) Order 1992

Notice is hereby given that on 15th May 1992, Cumbria County Council made an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984. The Order comes into operation on 29th May 1992, and its effect will be to prohibit waiting on the lengths of road specified in the Schedule to this notice.

Exemptions will permit waiting for the purposes of picking-up and setting down passengers, the loading and unloading of goods, in connection with a wedding or a funeral, the maintenance of roads and the supply of statutory undertakers services and emergency services therein. An exemption will permit the waiting of disabled persons' vehicles in accordance with the "orange badge" scheme.

A copy of the Order, together with a plan showing the lengths of road concerned and a statement of the Council's reasons for making the Order may be inspected at the Post Office, Main Street, Great Broughton, and at the offices of the undersigned during normal working hours.

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the ground that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 15th May 1992, apply to the High Court for this purpose.
