### THE PETROLEUM (PRODUCTION) (SEAWARD AREAS) REGULATIONS 1988

The Secretary of State for Trade and Industry invites interested persons, in accordance with the Petroleum (Production) (Seaward Areas) Regulations 1988 (SI 1988 No. 1213), as amended by the Petroleum (Production) (Seaward Areas) (Amendment Regulations) 1990, to apply for petroleum production licences in respect of blocks 39/1 and 39/2, as delineated on maps deposited in the Library at the Department of Trade and Industry, 1 Palace Street, London SW1E 5HE. The maps may be inspected by prior appointment (telephone 071-238 3042) between 9.15 a.m. and 16.45 p.m. Monday to Friday.

2. This invitation does not form part of the 14th Round of Offshore Licensing announced in the *London Gazette* on 6th March.

#### *Application for Licences*

3. In respect of the blocks listed at paragraph 1 above:

- (a) applications should be made on a standard application form available from the Department of Trade and Industry at the address given at paragraph (2) above (telephone 071-238 3211/3212);
- (b) applications should be delivered to the Oil and Gas Division of the Department of Trade and Industry at 1 Palace Street, London SW1E 5HE, between 9.30 a.m. and 12 noon on Wednesday, 2nd September 1992, together with a remittance in respect of the appropriate application fee of £3,700 in respect of each block applied for;
- (c) no applications will be accepted after 12 noon on 2nd September 1992;
- (d) applicants are requested to provide details of the work programme, comprising exploration or appraisal or pre-development activities they propose to carry out if awarded a licence;
- (e) applicants should note that they are requested to submit a statement of their policy with regard to the environment;
- (f) further guidance on the material with which applicants may support their applications is given in Guidance Notes available from the Department of Trade and Industry.

#### *Consideration for and Conditions of Licences*

4. Licences issued in respect of the blocks specified in paragraph 1 above will be subject to paragraph 2, 3, 4, 6, and 9-11, of the invitation of applications for petroleum production licences announced in the *London Gazette* on 6th March 1992. All references in that announcement to the "Department of Energy", should now be read as references to the "Department of Trade and Industry".
