6th May 1992

The QUEEN has been graciously pleased to ordain that Simon Aubrey Robin Hood Hastings-Bass, John Peter Robin Hood Hastings-Bass and Emma Alice Mary Balding shall henceforth have, hold and enjoy the same title, rank, place, preeminence and precedence as the sons and daughter of an Earl which would have been due to them had their father Peter Robin Hood Hastings-Bass survived his kinsman Francis John Clarence Westenra Plantagenet, Earl of Huntingdon and thereby succeeded to the title and dignity of Earl of Huntingdon.

And to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms. (16 SI)
