HIGHWAYS ACT 1980

The Raglan to Llandovery Trunk Road (A40) (Abergavenny Western Bypass) Order 199 and

The Raglan to Llandovery Trunk Road (A40) (Abergavenny Western Bypass Side Roads) Order 199

The Secretary of State for Wales hereby gives notice that he proposes to make the following Orders:

1. An Order under sections 10 and 12 of the Highways Act 1980 providing:

- (a) a road about 1.34 kilometres in length starting at a point on the Brecon Road (A40) 30 metres south east of the junction of Brecon Road (A40) with Pentre Road and terminating at a point on the Heads of the Valleys Road (A465), 370 metres west of the junction of the Heads of the Valleys Road with Merthyr Road (A4143).
- (b) that the length of the Ragian to Llandovery Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Gwent (who will become the highway authority responsible for that length), that the said new trunk road is open for through traffic.
- 2. An Order under sections 12, 14 and 125 of the Highways Act 1980.
 - (a) authorising him:
 - (i) to carry out the improvement of highways;
 - (ii) to stop up highways;
 - (iii) to construct a new highway;
 - (iv) to stop up private means of access to premises; and
 - (v) to provide a new means of access to premises.

all on or in the vicinity of the route of the new trunk road mentioned above; and

(b) providing for the transfer of each new highway to the County Council of Gwent as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the above-named draft Orders and of the relevant plans may be inspected, free of charge, at all reasonable hours from 18th June 1992 until 30th July 1992 or within 6 weeks from the date of publication of this notice, whichever period shall expire later at the Offices of: (i) Gwent County Council, County Hall, Cwmbran,

- (ii) Monmouth Borough Council, The Town Hall, Abergavenny,(iii) Llanfoist Post Office, Llanfoist, Abergavenny,
- (iv) The Stanhope Street Post Office, Stanhope Street, Abergavenny,
- (v) Welsh Office, Highways Directorate, Phase 1 Government Buildings, Ty Glas Road, Llanishen, Cardiff.

Any person may, not later than 30th July 1992 or within 6 weeks from the date of publication of this notice, if such period shall expire later, object to the making of either of the Orders, by notice in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting ref. ZB 760005-310-1 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection or representation may be communicated to other people who may be affected by it.
