GREAT GRIMSBY BOROUGH COUNCIL

*The Borough of Great Grimsby (Various Streets) Restriction of Waiting (No. 74) Order 1992*

Notice is hereby given that the Great Grimsby Borough Council, acting as agent for the Highway Authority, the County Council of Humberside, on 15th June 1992, made a Road Traffic Order under powers contained in the Road Traffic Regulation Act 1984, which will come into operation on 16th June 1992.

The effect of the Order is as follows:

1. To introduce restrictions for no waiting at any time in:

(a) *Town Hall Square* (car park access road to west of the Town Hall) on the east side from the southern kerb-line of Town Hall Square to a point 8 metres south thereof; on the west side, from the southern kerb-line of Town Hall Square to a point 16 metres south thereof; and on the west side from a point 27 metres south of the southern kerb-line of Town Hall Square to a point 37 metres south thereof.

(b) *Weelsby Avenue*, on the east side from a point 14 metres south of the southern kerb-line of Weelsby Road to a point 29 metres south thereof.

(c) *Legsby Avenue*, on both sides, from the northern kerb-line of Patrick Street to a point 11 metres north thereof.

(d) *Patrick Street*, on the north side, from a point 6 metres west of the western kerb-line of Legsby Avenue, to a point 6 metres east of the eastern kerb-line of Legsby Avenue.

(e) *Fisherman's Wharf*, on both sides, for the whole length.
