*Gwent County Council (A4042 Malpas Road, Newport) (Traffic Regulation) Orders 1992*

Notice is hereby given that the Gwent County Council, in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consultation with the Chief Officer of Police have, on 18th June 1992, made the above Order.

The Order will come into operation on 22nd June 1992.

The effect of the Order will be:

1. To revoke:

- (i) Items 1(a) to (h) in Schedule 3, (a) and (c) in Schedule 4, and (a) and (c) in Schedule 6 of the County Council of Gwent (A4042 Malpas Road, Newport) (Waiting and Loading Restrictions) Order 1983, as they relate to Malpas Road, and
- (ii) The Gwent County Council (A4042 Malpas Road, Newport) (Prohibition and Restriction of Waiting) Order 1989.

2. To prohibit waiting at any time on the lengths of road as set out in Schedule 1 to this notice.

To restrict waiting between the hours of 7 a.m. to 8 p.m. on any day on those lengths of road as set out in Schedule 2 to this notice.

To restrict waiting between the hours of 8 a.m. to 9.30 a.m. (Monday to Saturday) on that length of road as set out in Schedule 3 to this notice.

To introduce a 20 minute limited waiting (no return within 40 minutes) between the hours of 9.30 a.m. and 6 p.m. (Monday to Saturday) on that length of road set out in Schedule 4 to this notice.

Exemptions have been included in the Order to permit waiting for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading or unloading goods;
- (c) The maintenance of the roads;
- (d) The supply of gas, water or electricity;
- (e) For emergency purposes;
- (f) Local Authority duties.

3. To prohibit right hand turns on the lengths of roads as set out in Schedule 5 to this notice.
