## The Norfolk County Council (A1151 Wroxham/Hoveton Bypass) (Classified Road) (Side Roads) Order 1990

The Secretary of State for Transport hereby gives notice that he has confirmed with modifications the Norfolk County Council (A1151 Wroxham/Hoveton Bypass) (Classified Road) (Side Roads) Order 1990 which was made by the County Council of Norfolk under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, authorises the Council:

(a) to carry out the improvement of highways,

- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises,

all on or in the vicinity of the route of the Classified Road which the County Council is proposing to construct from a point on the existing A1151 Norwich Road, 500 metres south-west of its junction with C284 Salhouse Road, Wroxham, north-eastwards for a distance of 4.11 kilometres to a point on the existing A1151 Stalham Road, Hoveton, 250 metres north-east of its junction with the C398 Long Lane.

during all reasonable hours at the offices of the Norfolk County Council, County Hall, Martineau Lane, Norwich, and during opening hours at Wroxham Branch Library, Norwich Road, Wroxham.

Any person aggrieved by the Order, and desiring to question the validity thereof, or of any provision contained therein, on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 1st July 1992 apply to the High Court for the suspension or quashing of the Order, or of any provision contained therein.
