Parking places and waiting restriction amendments-Chesham Place

The general effect of the Waiting and Loading Restriction Amendment Order would be further to amend the City of Westminster (Waiting and Loading Restriction) Order 1976, so that in Chesham Place, the south-east side of the north-east to south-west arm, between a point 4.6 metres south-west of a point opposite the party wall of Nos. 34 and 35 Chesham Place and a point 18.4 metres north-east of that party wall, the hours during which the existing prohibition applies on:
