(e) the use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above;

(f) the mitigation of adverse effects which the existence or use of the said new trunk road and other highways which he proposes to construct or improve will have on their surroundings, and

(g) being given for land which forms part of Brent Park.

Proceedings on the draft Orders are being taken concurrently in accordance with section 257 of, and paragraph 20 in Schedule 1 to,

the Highways Act 1980.

The application to the Secretary of State for the Environment is for a certificate, under section 19 of the Acquisition of Land Act 1981, that he is satisfied as to the giving of land on the south side of London Underground Limited's Northern Line and on the east of the A406 Trunk Road, also land on the south of Brentview House and on the west of the A406 Trunk Road, in exchange for open space land included in the compulsory purchase order mentioned above.

Copies of the draft Order and of the plans referred to in them have been deposited, and may be seen at all reasonable hours, free of charge, at the Department of Transport, London Regional Office, 2 Marsham Street, London SWIP 3EB; and at the offices of the London Borough of Barnet at the Town Hall, The Burroughs, London N.W.4; and at Barnet House, 1255 High Road, Whetstone, London N.20; the Golders Green Library, 156 Golders Green Road, London N.W.11; and at Hendon Library, The Burroughs, London N.W.4.

The Inspector will hear representations from statutory objectors, as defined in the Compulsory Purchase by Ministers (Inquiries Procedure) Rules 1967 so far as concerns the Order numbered 3. above, and in the Highways (Inquiries Procedure) Rules 1976 so far as concerns the other Orders named above. He will also, at his discretion, hear representations from any other persons who may desire to appear and be heard, so far as concerns the Orders. He will hear representations from all persons interested so far as concerns the application for a certificate under section 19 of the Acquisition of Land Act 1981.

Objectors are reminded that the substance of any objection or representation may be communicated to other people who may be affected by it; that it will be passed to the Inspector holding the inquiries; and that he may be required to disclose at the inquiries the objection or representation and, unless there are special reasons to the contrary, the identity of the author.

The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the inquiries to submit:

- (a) that any highway or proposed highway to which any of the draft Orders relates should follow an alternative route; or
- (b) that instead of improving, diverting or altering a highway to which a draft Order relates, a new highway should be constructed on a particular route;

shall send to the Secretary of State for Transport at the Department of Transport, Room C6/16, 2 Marsham Street, London SW1P 3EB, not later than 17th July 1992, sufficient information about the alternative route or the route of the new highway to enable it to be identified. Failure to comply with this direction will entitle the person holding the inquiries and the Secretaries of State to disregard so much of any objection as consists of such a submission.

Deep frozen bovine semen from Member States of the European Community at ports/airports in England until further notice or unless revoked by the Minister.

This licence hereby revokes England General Import Licence No. 91/BS/1.

This licence comes into force on 1st July 1992.

Conditions for the importation under general licence of deep frozen bovine semen collected and processed on or after 1st January 1990

- 1. All landings of semen must be in accordance with the provisions of the Importation of Bovine Semen Regulations 1984, and with the following provisions of this licence.
- 2. Each consignment of semen shall be accompanied at all times by a health certificate in accordance with Council Directive 88/407/EEC laying down the animal health requirements applicable to intra-Community trade in and imports of deepfrozen semen of domestic animals of the bovine species, as amended by Council Directive 90/120/EEC. The certificate must be signed by an official veterinarian of the exporting country, consist of a single form drawn up in at least English and be made out to a single consignee.

3. Each consignment of semen must be transported in a flask sealed

in the presence of the certifying veterinary officer.

4. The flask shall be clearly marked with the name and address of the dispatching collection centre and the number(s) of the health certificate referred to at 2 above.

Consignees must notify, in writing, the local Divisional Veterinary Officer of the Ministry of Agriculture, Fisheries and Food, of their intention to import semen, in particular the nature of the consignment and the anticipated arrival date. Such notifications must arrive at least 24 hours in advance of the expected date of

6. On entry the health certificate must be presented to HM Custons and Excise for checking and endorsement and then accompany the consignment to its final destination* where it should be retained for a minimum period of 12 months for presentation to the Ministry on request.

A veterinary inspector shall have power to inspect all consignments (and accompanying certification) imported into Great Britain from another Member State at the place of destination.

8. A veterinary inspector shall have power to inspect consignments and accompanying documentation at any place and at any time where the Ministry has information leading it to suspect an infringement.

NOTE:

Any expressions used in this licence have the same meaning which they bear in the Animal Health Act 1981.

This licence applies only to consignments of deep frozen bovine semen collected and processed on or after 1st January 1990. Any person wishing to import frozen bovine semen collected and processed before 1st January 1990 should apply for a specific import licence to the appropriate address below:
