*The Corby District Council (A427/Station Road Junction, Corby) (Prohibition of Waiting) Order 1992*

Notice is hereby given that the Corby District Council, pursuant to arrangements made with the Northamptonshire County Council under section 101 of the Local Government Act 1972, proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984, and of all other enabling powers.

The effect of the proposed Order is to prohibit waiting at any time in the length of road described in the Schedule to this notice.

*A427/Station Road Junction/Oakley Road/Weldon Road*

South kerb-line of the west bound carriageway:

From the intersection of the east kerb-line of St. Marks Road with the south kerb-line of the A427, a distance of 110 metres in an easterly direction.

From the intersection of the west kerb-line of St. Marks Road with the south kerb-line of the A427, a distance of 37 metres in a westerly direction including the bus stop area.

North kerb-line of the east bound carriageway from the intersection of the west kerb-line of Station Road with the north kerb-line of the A427, a distance of 117 metres in a westerly direction including the bus stop lay-by to a point 13 metres north of the intersection on the access to Station Road, a total distance of 121 metres.

*Derbyshire County Council (Hassock Lane, Shipley) (Restriction of Waiting) Order 1992*

Notice is hereby given that Derbyshire County Council made an Order on 2nd July 1992, under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, prohibiting the waiting of vehicles on:

Lengths of road at Hassock Lane North/Hassock Lane South, Shipley:

(1) On the north-east side, from a point approximately 64 metres north-west of its junction with The Field in a south-easterly direction to a point approximately 400 metres south-east of its junction with Pit Lane.

(2) On the south-west side from a point approximately 40 metres north-west of its junction with The Field in a south-easterly direction to a point approximately 400 metres south-east of its junction with Pit Lane.

The Order will be effective from 6th July 1992.

Anyone wishing to question the validity of the Order on the grounds that it is outside the powers of the Act or because it does not comply with its requirements or of any regulation made under it, may within 6 weeks of the date of the Order apply to the High Court for this purpose.
