The County of Gwynedd (A496 Aberamffra, Barmouth) (Prohibition of Waiting) Order 1992

Notice is hereby given that the County Council of Gwynedd proposes to make an Order under sections 1(1) and (2), 2(1) to 2(3) and 4(2) of the Road Traffic Regulation Act 1984.

The effect of the Order will be:

(1) To prohibit waiting on the following sides of lengths of road:

A.496 Aberamffra:

(i) On the northerly side from a point adjoining the end of No. 5 Glanaber Terrace for a distance of approximately 830 metres in an easterly direction to the entrance to Aberamffra Harbour.

(ii) On the southerly side from a point adjoining the end of No. 5 Glanaber Terrace in an easterly direction up to No. 2 Porkington Terrace.

(iii) On the southerly side from a point adjoining No. 11 Porkington Terrace in an easterly direction up to the entrance to Aberamffra Harbour.

(2) To revoke the existing seasonal restriction on the above sides of lengths of road.

- (b) loading or unloading goods;

and where necessary in connection with:

- (c) certain building operations;
- (d) the maintenance of the road;
- (e) the supply of gas, electricity, water or other statutory undertakings;
- (f) the exercise of local authority powers and functions;
- (g) the exercise of postal functions;
- (h) fire brigade, ambulance and police purposes;

(i) and in certain circumstances when the vehicle is a disabled person's vehicle.
