(b) Waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period for more than 20 minutes in the same place is prohibited between 11 a.m. and 6.30 p.m. on Monday to Saturday inclusive in the streets.

(c) In the streets, the sale or offer for sale of goods from a vehicle is prohibited, except on a Sunday unless there is in force a valid licence issued by the London Borough of Havering or the goods are immediately taken or delivered at premises adjacent to the vehicle from which the sale is affected.

(d) In the streets the use of any vehicle or any animal or of the wearing of fancy dress or any other costume wholly or mainly for the purpose of advertising is prohibited.

(e) The prohibited referred to in paragraph 2(a) and 2(b) above do not apply in respect of anything done with the permission or as a direction of a police constable in uniform or in certain circumstances e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol etc. from the road side petrol stations, to licensed street traders etc. The usual exemption relating to vehicles displaying a disabled persons orange badge will apply.

4. The general effect of the Free Parking Places Order 1992 will be that of the 154 metres of the existing free car parking places on the west side of the Walk 100 metres will be designated as free parking places for buses (designed to carry eight or more passengers excluding the driver) while the remaining 54 metres will continue as

free car parking places.
