

ROAD TRAFFIC ACTS

DONCASTER BOROUGH COUNCIL

(A) *The Doncaster Borough Council (County Borough of Doncaster) (Off-Street Parking Places) Order 1967 (Car Park No. 1, Cleveland Street Roundabout) (Amendment) Order 1992.*

(B) *The Doncaster Borough Council (Borough of Doncaster) (Car Park No. 3, Church Way, Doncaster) (Off-Street Parking Places) Order 1977 (Amendment) Order 1992.*

(C) *The Doncaster Borough Council (County Borough of Doncaster) (Off-Street Parking Places) Order 1967 (Car Park No. 2, North Bridge) (Amendment) Order 1992.*

Notice is hereby given that on 29th June 1992 the Doncaster Borough Council made the above-named Orders under sections 35(1) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of Orders (A) and (B) above would be to alter the system of initial charges and initial period of stay as follows for the Council's multi-storey car parks at Cleveland Street Roundabout and Church Way, Doncaster:

£1.60: over 4 hours (not exceeding 20 hours).

The system will still be operated by way of pay and display and failure to comply with the provisions as to the initial charges will result in the levy of an excess charge of £20 reduced to £10 if paid within twenty-one days. Season ticket prices of £212 per year, or £53 per quarter are valid on a five day Monday to Friday basis, and £232 per year or £58 per quarter are valid on a seven day Monday to Sunday basis.

The effect of Order (C) above, would be to alter the system of initial charges and the initial periods of stay for the Council's Multi-Storey Car Park at North Bridge, Doncaster as follows:

60 pence: up to 2 hours.

£1.20: up to 4 hours.

£2.00: Over 4 hours (not exceeding 20 hours).

An increased excess charge of £20 (reduced to £10 if paid within twenty-one days of being incurred) will apply to all the above car parks for failure to comply with the provisions as to the initial charges. Season ticket prices of £288 per year or £72 per quarter are valid on a five day Monday to Friday basis, and £308 per year or £77 per quarter are valid on a seven day Monday to Sunday basis.

The Orders will come into operation on 9th July 1992. Copies of the Orders may be examined at the offices of the Borough Solicitor, Copley House, Waterdale, Doncaster, between the hours of 8.45 a.m. and 4.45 p.m. Mondays to Fridays (inclusive).

If you wish to question the validity of the Orders or of any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it have not been complied with in relation to the Orders, you may within 6 weeks from 6th July 1992, apply to the High Court for this purpose.

Heath Close, both sides, from its junction with *Glen Road* for a length of 10 metres in a southerly direction.

Glen Road, south side, from the east and west kerb-lines of *Heath Close* for lengths of 10 metres in an easterly and westerly direction.

2. *Prohibition of entry—except for access*

Heath Close, Norton, Swansea, from its junction with *Glen Road*.

Leeds City Council (Traffic Regulation) (No. 13) Order 1992

The Ashtons and The Ashleys, Leeds 8, Residents Parking Scheme and Waiting Restrictions

Notice is hereby given that the Leeds City Council proposes to make the above Order under the powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to:
