 - (b) loading or unloading goods.
 - (c) the maintenance of the roads.
 - (d) the supply of gas, water or electricity.
 - (e) for emergency purposes.
 - (f) local authority duties.

3. A 40 m.p.h. Speed Limit Order to be introduced on the following lengths of road:
 - (i) Route A4046, Station Road, Waunlwyd to Town Bypass Road, Ebbw Vale. From a point 200 metres north of its junction with route B4486 Dyffryn Road, Waunlwyd to a point 70 metres north of its junction with The Walk, Ebbw Vale.
 - (ii) Route A4046 North West Approach Road, Ebbw Vale. From a point 30 metres north of its junction with Tredegar Road, Ebbw Vale, to its junction with the Cemetery Corner Roundabout.
4. A 24 Hour Main Carriageway Clearway Order to be introduced on the following length of road:

Route A4046 Station Road, Waunlwyd to Town Bypass Road, Ebbw Vale from a point 200 metres north of its junction with Route B4486 Dyffryn Road, Waunlwyd, to a point 70 metres north of its junction with The Walk, Ebbw Vale.
